Shinde elaborated roles & responsibilities of Mentoring & Anti Ragging Committee & Squad members as per All Indian council for Technical Education notified Regulation for prevention & prohibition of ragging in AICTE approved Technical Institutions vide No. 37-3/Legal/AICTE/2009. He further mentioned that Anti – ragging Committee will be responsible for redressal of complaint for the time being in force concerning ragging. Sir also mentioned committee should also make an annual report of the complaints & action taken by them to the head of institute.

3. **To converse about preparation and maintenance of anti- ragging affidavits record.**
Resolution: Discuss about maintaining of the proper records of anti-ragging affidavits obtained from students.

Actionable point

Ms. D. A. Uthale is directed to maintain anti ragging affidavits records.

4. **To prepare instructions for students**
Resolution: For prevention of ragging, measures to be taken as to display anti-ragging instructions for students on student notice board, in information brochure, conveying that ragging lined in institute by members of committee to students.

5. **To give information about prevention, actions to be taken after ragging to new comers.**
Resolution: To make aware fresher's & new admission candidates of dehumanizing effect of ragging and warning of ragging is totally banned otherwise liable for punishment under law.


6. **To acquaint students, faculties with working of Anti – ragging Committee & squad.**
Resolution: Anti-ragging committee & squad carried out orientation session with students to sensitize them about the working of anti-ragging committee. Mrs. U.R. Bheda madam also guides students and also discussed about provisions of the act, the committee stressed the need to increase awareness among the students on how the rules have been amended to prevent instance of force concerning ragging.
